I also hereby individually and on behalf of my heirs, executors and assignees, release and hold the Weed Warriors, the City of Newcastle, its officials, employees and agents and waive any right of recovery that I might have to bring a claim or a lawsuit against them for any personal injury, death or other consequences occurring to me arising out of my volunteer activities, except for those caused by the sole negligence of the City of Newcastle.
